



## Volunteer Release and Waiver of Liability Form

This Release and Waiver of Liability (“the release”) executed on \_\_\_\_\_(date) by \_\_\_\_\_ (“the Volunteer”) releases Redding Christian Fellowship, a religious corporation organized and existing under the laws of the State of California, and each of its directors, officers, employees, and agents. The Volunteer desires to provide volunteer services for Redding Christian Fellowship and engage in activities related to serving as a volunteer.

The Volunteer understands that the scope of the Volunteer’s relationship with Redding Christian Fellowship is limited to a volunteer position and that no compensation is expected in return for services provided by the Volunteer; that Redding Christian Fellowship will not provide any benefits traditionally associated with employment to the Volunteer; and that the Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of the Volunteer’s services to Redding Christian Fellowship.

1. **Waiver and Release:** I, the Volunteer, release and forever discharge and hold harmless Redding Christian Fellowship and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to Redding Christian Fellowship. I understand and acknowledge that this Release discharges Redding Christian Fellowship from any liability or claim that I may have against Redding Christian Fellowship with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to Redding Christian Fellowship or occurring while I am providing volunteer services.
2. **Insurance:** Further, I understand that Redding Christian Fellowship does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of Redding Christian Fellowship beyond what may be offered freely by Redding Christian Fellowship in the event of injury or medical expenses incurred by me.
3. **Medical Treatment:** I hereby release and forever discharge Redding Christian Fellowship from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with Redding Christian Fellowship.
4. **Assumption of Risk:** I understand that the services I provide to Redding Christian Fellowship may include activities that may be hazardous to me including, but not limited to lifting, cleaning, tools, moving parts/vehicles \_\_\_\_\_, involving inherently dangerous activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and release Redding Christian Fellowship from all liability.
5. **Photographic Release:** I grant and convey to Redding Christian Fellowship all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or

voice made by Redding Christian Fellowship in connection with my providing volunteer services to Redding Christian Fellowship.

6. **Other:** As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California and that this Release shall be governed by and interpreted in accordance with the laws of the State of California. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
